Activation of Session II of the competition for admission to PhD courses - XXXVIII cycle - at the University of Insubria for the academic year 2022/2023

Disclaimer: this document is a summary in English language of the original and legally binding document drawn in Italian language, it has no legal value and it is intended to provide foreign applicants with the basic information and instructions

It gives communication:

- 1. It is published the Call Forms XXXVIII cycle Session II attached to the Call Protocol n. 593 of June 28, 2022 indicating the banned positions;
- 2. to fully apply the Rector's Decree n. 593 of June 28, 2022 with which the competition for admission to the XXXVIII cycle of PhD courses with administrative headquarters at the University of Insubria was launched, except as specifically regulated in this decree;
- 3. to allow candidates to express at least one preference for the project grants indicated in the call by filling in the questionnaire available at the online registration until 22 August 2022 at 12 noon. This preference will be considered as a mere expression of interest and will not be binding. The candidate must upload at least one project;
- 4. for the purpose of assigning grants, the Commission may decide to assign a candidate a project grant for which he has not expressed an interest during the registration phase but taking into account the overall evaluation of the candidate's curriculum;
- 5. for places pursuant to D.M. 352 of April 9, 2022 co-financed with companies, candidates can apply for a maximum of 2 positions, also referring to different courses. For these positions, in addition to the provisions of the D.R. n. 593 of June 28, 2022, it is necessary to upload the research project relating to the topics of the chosen position, (Annex of Call for Proposals XXXVIII cycle Session II). It is necessary to present a specific project for each of the scholarships ex D.M. 352 choices;
- 6. to specify that the places pursuant to the D.M. 352 of 9 April 2022 will be assigned as listed below, without prejudice to the provisions of art. 6 of the D.R. rep. n. 593 of 28 June 2022:
 - if the candidate is suitable for two scholarships, he will be included in the respective rankings on the basis of the score achieved;
 - the Commission also reserves the possibility of assigning a candidate who was found to be suitable and not awarded, to a scholarship not chosen during the registration phase as long as it is within the same course, based on the overall evaluation of the candidate;
- 7. to confirm that the submission of the application for admission to the competition, for which candidates must connect to the Student Secretariat Web Services in accordance with the procedures set out in art. 3 of the D.R. rep. n. 593 of June 28, 2022, entails, under penalty of exclusion, the commitment by the candidate:
 - to carry out the research periods envisaged in the company or at an institution and abroad as per the chosen project, and as indicated in the Ministerial Decree 352 and 351 of 9 April 2022;

- to report on the activities carried out in accordance with the provisions of the D.M. 352 and 351 of 9 April 2022;
- to respect the principle of not causing significant damage to the environmental objectives, pursuant to Article 17 of Regulation (EU) 2020/852 and to ensure consistency with the PNRR positively assessed by the ECOFIN Council Decision of 13 July 2021;
- 8. to confirm that, during the registration phase for the competition for all positions in Session II, once the online application has been completed, it will no longer be possible to modify or cancel it. While entering the application, and before the final confirmation, it will always be possible to cancel it and redo it completely;
- 9. to instruct the Doctoral and Postgraduate Training Office with the execution of this provision, which will be registered in the general repertory of decrees.
